Finance

The group met last week. Things are looking very good. The Auction was really good we ended at \$173,000 plus another \$10,000 for the fund a need.

Guardian Angels

The group is still working on the ornaments, and planning the bookfair. The bookfair will be in the library this year. Pizza and cookies will be in the cafeteria. There is still talk about a parent night out, but nothing has been planned at this time.

Julie will pull a list of new families and we can discuss distributing them at the next meeting.

Fundraising and Script

Script is rolling along. St. Vincent put in a large order of \$13,500, and Valley Medical is working on placing an order as well.

There were questions if Fazzari's and Hot Shots would be interested in doing Script. Hot Shots did sell them, but the cost of the cards was challenging, and therefore stopped participating.

We typically budget \$15K for Script each year, and get fairly close to that amount.

Christmas trees are going well. We have around 700-750 trees, down from 900. Volunteers list is going well. Unloading will be November 26, 2019. The trees are very difficult to get, and this may not be a viable fundraiser for the future.

There needs to be more discussion about fundraisers for the future. Maybe a creation of a sub committee to make a formal recommendation on future fundraisers.

Michele B. moved to open an account at P1FCU to put electronic tree sale funds into. The motion was seconded by Missy and passed with all in favor.

School Building

There has not been a meeting, there is informal communication about next steps, but nothing formal to share at this time.

Foundation Board/Annual Fund

The letter went out this month and so far we have \$2000.00 that has come in.

- Parent Satisfaction Survey (35 responses). #1 reason to send to ASCS was education and then Catholic Faith. Opportunities mentioned were online grades for the Jr. High, and onsite counseling. Communication is great, but would like more information about sports. We are already making many of these improvements to communication and online grades.
