Tuition payments are due at the beginning of each month and will be considered delinquent if not paid by the 10<sup>th</sup>. Tuition for the 2017-2018 school year must be paid in full by June 10, 2018. I understand that if tuition is thirty (30) days overdue, ASCS may impose any or all of the following sanctions at the school's sole discretion, unless special payment arrangements have been made in writing agreed upon by the principal.
